THE LOCATION

720 Red is well-situated in the heart of the Red River Cultural District in downtown Austin. This burgeoning area recently received cultural district status, which provides eligibility for state-level cultural recognition. The Red River Cultural District also stands to benefit from the Waller Creek Redevelopment, a public works project by the city of Austin that is intended to bring new development along the Red River corridor. The development is highlighted by five connected parks, which will include numerous hiking trails, breathtaking scenery, outdoor seating, retail and art spaces and various community programs including movie nights, open-air markets, and outdoor exhibitions. Moreover, the property is a short walk from "Sixth Street," Austin's renowned bar, music venue and restaurant district, and downtown entertainment and attractions along Congress Avenue, Rainey Street, and the Second Street District.




